## The next Erasmus+ Call for proposals

- Publication of the next Call is expected by the end of September 2016
- No major changes
- National and regional priorities for CBHE remain unchanged
- Focus on enhancing the quality of proposals and its innovative aspects
- To encourage new beneficiaries in the regions and new teams within experienced HEIs





## Information events (1)

- Focus on training “How to develop good project proposals?”
- Individual methodological seminars requested by university administration
- Please consider potential of Higher Education Reform Experts (HEREs)





### Information events (2)

- Universities should propose any appropriate event applying directly to the NEO or National team of HEREs
- Joint seminar with E+CBHE projects to explain specific features of project type and component, case study
- Best practice to be promoted and possible challenges shared
- Individual consultations with potential applicants after seminars





## Message to potential applicants (1)

- Please take into account specific needs of country and governmental decisions regarding HE system
- Institutional approach
- Careful search of appropriate partners from European universities and from local HEIs
- Careful study of developed projects with request to join consortium (in particular multi-country)
- Step by step instructions of the NEO (Пошаговая инструкция по подготовке заявки)





## Message to potential applicants (2)

- Please consider the completed and on-going projects in order to avoid duplication and consider synergy
- Please avoid contradiction to existing regulations
- Do not forget to involve specific public structures according to your project objective
- Please discuss financial issues during project development

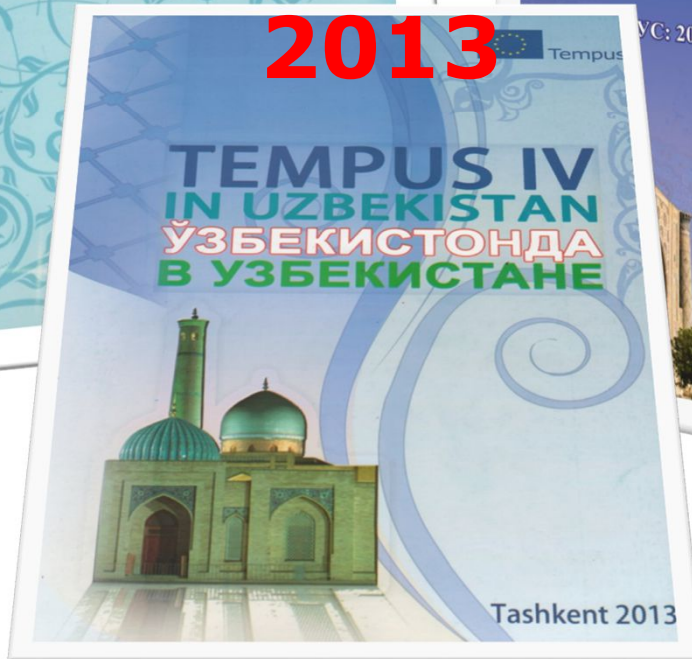
- Please establish project team according to project objectives

### 2<sup>nd</sup> round of applications - 2016

- Announced on 9<sup>th</sup> June 2016
- 8 National Agencies of Austria, Belgium, Cyprus, Denmark, Iceland, Malta, Netherlands and United Kingdom - for Central Asia
- EUR 500,000 for approximately 125 additional mobilities to and from Central Asian countries
- Deadline – 15 September 2016
- Please invite European professors to deliver lectures and cooperate with HSMC
