



- + 2 cross-regional






EU partner universities by country participating in CBHE projects in Uzbekistan within the 3rd Call

Involved universities from partner countries in CBHE projects within the 3rd Call










CBHE in brief

- 2. Structural Projects: Reforms at national level w/ support of authorities in Partner Countries (policy modernisation, Bologna policies, governance & management of higher education systems etc.) (UZ: 4 on-going SMs)








CBHE in Uzbekistan






